The Commission discussed getting traffic cameras installed on Elk and Allegheny Mountains. Gene McConnell suggested that the Commissioners from Randolph County and Pocahontas County be contacted to see if they would be interested in forming a cooperative effort to have them installed.

Upon motion of Carl Hevener, vote unanimous, the Commission signed the Animal Mortality Insurance renewal application for Kate, the County's search/rescue/drug dog.

Upon motion of Randy Roberson, vote unanimous, the Commission signed the Emergency Management Performance Grant (EMPG) 2014 Additional Allocation in the amount of \$3,484.53.

The Shentel Cable Franchise Agreement will be up for renewal in June 2018. They are requesting that the expiring ten year contract be replaced with a fifteen year contract. The Commissioners would prefer to keep it at ten years. The issue was tabled until Kevin Sponaugle, Prosecuting Attorney, reviews the proposed renewal contract.

On motion of Carl Hevener, vote unanimous, the Commission approved the annual renewal for the Storage Tank Liability Insurance in the amount of \$1,472.05, an increase of \$127.70 from last year.

Upon motion of Carl Hevener, vote unanimous, the Commission signed a records grant agreement with the WV Division of Culture & History in the amount of \$8,682 with a 10% county match for the encapsulation of old minute books and the hiring of a temporary, part-time person to do back-indexing in the County Clerk's Office.
