The Commissioners had some concern with the way the Resolution that was presented was written. They all thought it was too long and the word "sanctuary" was somewhat misleading. Carole Hartman, made a motion, vote unanimous, to table the discussion to enable them to review information and to draft a shorter resolution.

Cary Ours, with the South Branch Valley Day Report Center, presented the Memorandum of Understanding (MOU) with the Pendleton County Commission for the upcoming fiscal year. Carole Hartman, made a motion, vote unanimous, to sign the MOU and to budget the same amount of funding of \$17,666.66 as in prior years.

On motion of Carl Hevener, vote unanimous, Kevin Raymond will be appointed to the 911 Advisory Board contingent upon his written acceptance. He will be replacing Andrew Teter who has resigned.

On motion of Carole Hartman, vote unanimous, the Commission approved the contract with FP Mailing Solutions for a newer postage meter to replace the existing one which is no longer supported. The monthly rental fee will remain the same, \$62.45.

The Commission met with Kevin Sponaugle, Prosecuting Attorney and Donald Hedrick, Sheriff to review their office budgets for fiscal year 2021.

The December 2019 and January 2020 Sheriff's financial statements were reviewed.
