Minutes of the December 18, 2018 meeting of the County Commission were unanimously approved.

Maintenance:

The Commission discussed options for off-site storage locations.

Thomas Butcher from Mon Power discussed the recent power surge issue in Upper Tract and the repairs done to help alleviate the issue.

Becky McConnell and Sue Harper gave a presentation on the activities and programs at the Pendleton County Library for 2018. Becky discussed the improvements made to the Library in 2018 and the projected improvements for 2019. They requested continued financial support for the 2019-2020 fiscal year from the County Commission.

Laura Brown, Executive Director of Pendleton County Chamber of Commerce and Pendleton County Convention and Visitors Bureau (CVB) gave a presentation on the updated websites of the Chamber and the CVB. She stated that the Economic Development and the school system have also updated their websites. She recommended that the Commission update their website to link with the other organization's updated sites. She presented a proposal from Ryan Pace Communications Management, LLC in the amount of \$3,800 to design, develop and maintain a website for the County Commission. On motion of Carl Hevener, vote unanimous, the Commission agreed to accept this proposal.

The annual contract from Global Science and Technology for maintenance of all county computers was reviewed. The new rate will be \$680 per month, an increase of \$195 per month from previous contract. They have not increased our rate in several years. On motion of Carole Hartman, vote unanimous, the Commission approved and signed the new contract.

On motion of Carl Hevener, vote unanimous, the Commission renewed the rental agreement with the Division of Forestry for office space at Pendleton County Community Building for two years at a rate of \$100 per month.

On motion of Carole Hartman, vote unanimous, Jim Brown was appointed to the Building Commission for a four-year term.

On motion of Carl Hevener, vote unanimous, three sheep claims were approved at the rate of \$75.00 per sheep killed by dogs and were properly verified by the Sheriff's Office.

Mileage reimbursement rates changed to 58 cents per mile as of January 1, 2019 in accordance with Internal Revenue Service rates.

The Commission discussed the placement of a traffic camera on top of Allegheny Mountain. Carole Hartman will contact Bruce Minor, Rick Gillespie and Randolph County Commission for information on what would be needed to install.

The Sheriff's monthly financial statements for November and December 2018 were reviewed.
