COMMISSIONERS PRESENT: CARL HEVENER, PRESIDENT AND ROGER DAHMER AND JIMMIE BENNETT

Commissioner Dahmer led those present in prayer. Commissioner Hevener opened the meeting.

Minutes of the October 17, 2023 meeting of the County Commission, on motion of Commissioner Dahmer, were unanimously approved.

Maintenance: No major issues.

Karen Pitsenbarger, County Administrator, gave a report on 911 and Emergency Management as Diana Mitchell and Rick Gillespie were unable to attend the meeting. A letter from Mike Alt, Pendleton County Emergency Rescue (PCER), recognizing Darren Taylor for his prompt actions during a cardiac incident at the Department of Motor Vehicles on October 26, 2023. The actions of Mr. Taylor played a large part in the positive outcome for this patient. The PCER wishes to formally thank him for his support.

On motion of Commissioner Bennett, vote unanimous, the Commission signed the grant application for the proposed tower site in Seneca Rocks.

Mr. Gillespie also sent an email stating that Homeland Security had awarded the County a \$25,000.00 grant towards replacement of obsolete radios.

Laura Brown, Seneca Rocks Regional Development Authority Director (SRRDA), informed the Commission they had been awarded a \$99,000.00 grant to be used to make the old Board of Education building an innovation hub.

Ms. Brown also said that MonForest Towns was working with three towns towards establishing a regional planning commission and a regional comprehensive plan. The Benedum Foundation will be awarding a \$75,000.00 grant in January. She believes that the SRRDA has a good chance of being the recipient of this grant.

Scott Somerville submitted a draft requesting the Commission to appoint a Planning Commission that would then create a strategic plan. He stated that a regional planning commission would be good for this area, but doesn't feel it would be strong enough to allow the Commission to issue a moratorium for wind turbines. On motion of Commissioner Dahmer, vote unanimous, the request was tabled until they see what the regional plan comes up with.

Commissioner Dahmer spoke to Mr. Somerville regarding the statements he previously made about supporting a candidate to run against Commissioner Dahmer who would vote in favor of creating a planning commission. Commissioner Dahmer stated that he had felt threatened by that statement and that he had taken no donations from anyone towards his campaign expenses last year. Mr. Somerville admitted that he was wrong to have said that and apologized for his threats. He did continue saying that he felt the wind turbines were heading to this County and wants the Commission to fight them, so he will try to find a candidate to replace Commissioner Dahmer.

On motion of Commissioner Dahmer, vote unanimous, the Commission approved the second budget revision for General County for fiscal year 2024.

A conference call between the County Commission, Omni Architects, Supreme Court, and Judge Charles Carl was made to discuss the current floor plans for the Courthouse Annex. During review and discussion, some changes were made to the plans. A follow-up conference call was scheduled for Tuesday, November 14, 2023 at 12:30 p.m.

Sheriff Chad Bowers informed the Commission that he had received nine applicants for the court security position. He also stated that they may need to advertise for a chief deputy.

The Commission discussed the health insurance premiums. Highmark Blue Cross Blue Shield submitted a renewal plan with a 7.41% increase in premiums. On motion of Commissioner Dahmer, vote unanimous, the Commission agreed to keep the current plan as is with the County paying 88% of the premium and the employee paying 12%.

There was discussion on the number of hours that the 911 dispatchers must work to keep a status of full-time with benefits. The Commission agreed that in order to keep full-time status and be eligible for benefits, a dispatcher must work 80 hours in a pay period.
