AT A COUNTY COMMISSION HELD FOR PENDLETON COUNTY, WEST VIRGINIA, AT THE COURTHOUSE, ON TUESDAY, OCTOBER 15, 2024 AT 9:00 A.M.

COMMISSIONERS PRESENT: CARL HEVENER, ROGER DAHMER AND JIMMIE BENNETT

Commissioner Dahmer led those present in prayer. Commissioner Hevener called the meeting to order.

Minutes of the October 1, 2024 meeting of the County Commission, on motion of Commissioner Dahmer, were unanimously approved.

Maintenance:

Karen Pitsenbarger received a quote of just over \$48,000 for replacing HVAC units at the Pendleton County Community Building (PCCB) for several offices.

Rick Gillespie, Emergency Services Coordinator, gave the Commissioners a heads up on potential upgrades for the 911 system. He stated that upgrading to the Next Generation 911 (NG911) is not yet mandatory but expects it to be made so in the near future. The upgrade would allow for citizens to send texts, videos or other data during an emergency call to the 911 Center. He estimates the cost could be anywhere from \$70,000 - \$100,000.

Mr. Gillespie reported that the steel has arrived for the Seneca Rocks Tower and the foundations have been dug and prepped for the building and generator. The weather will play a factor as to when they can begin constructing the tower.

He also mentioned in regards to the Elk Mountain camera, that the vendor that VDOT had been using no longer handles this area. A new company, Parsons, has been contacted and are currently waiting on a quote from them for installing the camera.

The Commission met with the USDA on the Courthouse Annex and are waiting for approval to go to bid. Omni will be submitting new drawings for the handicap ramp by the end of the next day. Lance Construction is ready to start on October 21.

Mike Alt submitted the request from PCER for the third quarter EMS Salary Enhancement funds in the amount of \$56,740.25. He stated they averaged 105 calls per month, with 90 of them including transport. The response time has remained at an average of thirty-three minutes.

The extension agency has requested funds for the Energy Express program for youth during the summer. They currently need an additional \$10,000 for the program. On motion of Commissioner Dahmer, vote unanimous, the request was tabled to the next meeting for additional information.

The Pendleton County Public Service District board appointment was tabled until the next meeting.

On motion of Commissioner Dahmer, vote unanimous, an application and Resolution for the Records Management and Preservation Grant for personnel to do scanning and indexing in the County Clerk's Office in the amount of \$10,000 was signed.

On motion of Commissioner Dahmer, vote unanimous, the Commission will sign a letter of support for the South Branch Valley Day Report Center to obtain a grant for an opioid program.

The Commission discussed the health insurance premiums. Highmark Blue Cross Blue Shield submitted a renewal plan with a 5.66% increase in premiums. On motion of Commissioner Dahmer, vote unanimous, the Commission agreed to keep the current plan as is with the County paying 88% of the premium and the employee paying 12%.

The Commission reviewed the September employee timesheets.

The following appointments of administrators, executors, etc., done by the County Clerk in vacation of the Commission were approved on motion of Commissioner Bennett, vote unanimous.
